i. *The above revised rate will be applicable in case of single publication in print media as well as single event management on the scheduled date of public hearing. The project proponent will bear actual cost over and above revised rates.*

ii. *The enhanced rate of Public hearing fees will be effective w.e.f. date of issuance of this office order until further order.*

The fees must be paid through a Bank draft drawn in favor of **Member Secretary, State Pollution Control Board, Odisha** payable at **Bhubaneswar** and should be enclosed along with the application for Public Hearing by the project proponent.




