OFFICE ORDER

Revised classification of industrial units has been done by State Pollution Control Board, Odisha as per criteria and guidelines of Central Pollution Control Board and this Board has brought out office orders from time to time in this regard. As per CPCB direction dtd. 30.04.2020 U/s. 18 (b) of Water and Air PCP Act regarding harmonization of classification of industrial sector in to ROGW categories "Compressed / refined Bio-Gas production from Bio-degradable Wastes" has been categorized under Serial No. 86 of Orange category vide this office order No. 8909, dtd. 18.09.2020. Thereafter, a letter has been received from CPCB on dtd. 22.09.2021 w.r.t. revised categorization, which shall supersede the earlier categorization at Sl. No. 86 (Orange) i.e., from "Compressed / refined Bio-Gas production from Bio-degradable Wastes" to "Compressed Bio-Gas (CBG) / Bio -CNG Plants" and "household bio-digesters / Gobar Gas (Cow Dung) plants based on bio-degradable waste etc." as per the following table;
