Attention : Entities involved in the generation, transportation, storage, recycling, utilization, and disposal of hazardous wastes as per Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016.

CPCB, Delhi has developed "National Hazardous Waste Tracking System (NHWTS)" for tracking the generation, transportation, storage, recycling, utilization, and disposal of hazardous wastes across the country.

The NHWTS has modules for registration, daily records, e-manifest, geo-tracking of hazardous waste movement, filling of annual returns and dashboard. This application functions as single application for tracking the movement of hazardous waste and resolves the issues pertaining to interstate movement of hazardous wastes.

Module for registration of Industries can be assessed at <https://geo.nic.in/nhwts/> and also on the "E-Governance Portals" at the website of CPCB.

Further, all the Entities involved in the generation, transportation, storage, recycling, utilization, and disposal of hazardous wastes are required to obtain consent to establish (CTE) and Consent to Operate (CTO) under Water (PCP) Act, 1974 and Air (PCP) Act, 1981 and Authorization under Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016. Thereafter, they will register in the online portal of CPCB within 15 days of the publication of this notice.


