OFFICE ORDER

The process for following services have been made online by the State Pollution Control Board, Odisha.

- 1) Consent to Establish under the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981.
- 2) Consent to Operate under the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981.
- 3) Authorization under the Hazardous and Other Wastes (Management and Trans boundary Movement) Rules, 2016.
- 4) Authorization under Bio-Medical Waste Management Rules, 2016.
- 5) Authorization / Renewal under E-Waste Management Rules, 2016.
- 6) Registration / Renewal under Plastic Waste Management Rules, 2016.

Further to the implementation of the online system, it is notified that:

- 1) No physical/ manual application shall be required to be submitted by the applicants for the above services.
- 2) No physical copies of documents shall be required by the Authority in addition to which are uploaded at the time of submission of online application
- 3) The application shall be disposed off within the stipulated timeline as defined under ORTPS Act – 2012
- 4) Authorities shall accept downloaded digitally, manually signed certificates as valid and shall not require physically signed/ stamped certificate, however the applicant shall produce authentic copy of the respective documents on demand by the appropriate authority during inspection/ site visit.
- 5) The applicant shall not be required to get in touch with the authorities in person except in cases where inspection/ site visit is mandated by law.

The aforementioned services shall be granted online only and offline mode of grant / registration / renewal of the above mentioned services in the State shall be dispensed forthwith.
