Attention: Producers (any person or entity who, manufactures and sells new tyre domestically and/or sells domestically under its own brand, new tyre manufactured by other manufacturers or suppliers and/or sells imported new tyre and/or imports vehicles fitted with new tyres and/or automobile manufacturers importing new tyre for use in new vehicles sold domestically and/or imports waste tyre;), **Recycler of Waste Tyre** (any person or entity engaged in the process or action of converting waste tyre into reclaimed rubber and/or crumb rubber and/or crumb rubber modified bitumen (CRMB) and/or recovered carbon black, which is usable as raw material for manufacture of new tyre and/or pyrolysis oil or Char, which is used only as a fuel and not as raw material for manufacture of new tyre) and **Retreaders** (any person or entity engaged in the process of renewal of tread and side wall rubber of a worn out tyre having a good structural quality).

This is to bring to the notice that as per the Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2022, **Producers, Recyclers** of waste tyres and **Retreaders** of worn-out tyres shall have to register in the Extended Producers Responsibility (EPR) Portal of CPCB (<https://www.eprtyrespcb.in>). The new rules are available in the following links: <https://eprtyrespcb.in/rules/pdf/amendment-Rules-2022.pdf>.

As per the said rules,

- I. No entity shall carry out any business without registration.
- II. The entities registered under the portal shall not deal with any unregistered producer or recycler.
- III. Any registered entity furnishes false information or willfully conceals information for getting registration or return or report or information required to be provided or furnished under this Schedule or in case of any irregularity, the registration of such entity may be revoked by the Central Pollution Control Board for a period up to three years after giving an opportunity of being heard and in addition, environmental compensation charges may also be levied.
- IV. Any entity is covered in more than one category under paragraph 3, then the said entity shall register under those categories separately.
- V. The Central Pollution Control Board may charge such registration fees from the applicants as may be specified from time to time with the approval of the steering committee.

Attention: Producers (any person or entity who, manufactures and sells new tyre domestically and /or sells domestically under its own brand, new tyre manufactured by other manufacturers or suppliers and /or sells imported new tyre and /or imports vehicles fitted with new tyres and /or automobile manufacturers importing new tyre for use in new vehicles sold domestically and /or imports waste tyre;), **Recycler of Waste Tyre** (any person or entity engaged in the process or action of converting waste tyre into reclaimed rubber and /or crumb rubber and /or crumb rubber modified bitumen (CRMB) and /or recovered carbon black, which is usable as raw material for manufacture of new tyre and /or pyrolysis oil or Char, which is used only as a fuel and not as raw material for manufacture of new tyre) and **Retreaders** (any person or entity engaged in the process of renewal of tread and side wall rubber of a worn out tyre having a good structural quality).

This is to bring to the notice that as per the Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2022, Producers, Recyclers of waste tyres and Retreaders of worn-out tyres shall have to register in the Extended Producers Responsibility (EPR) Portal of CPCB (<https://www.eprtyrespcb.in>). As per the said rules,

Any registered entity furnishes false information or willfully conceals information for getting registration or return or report or information required to be provided or furnished under this Schedule or in case of any irregularity, the registration of such entity may be revoked by the Central Pollution Control Board for a period up to three years after giving an opportunity of being heard and in addition, environmental compensation charges may also be levied.
- IV. Any entity is covered in more than one category under paragraph 3, then the said entity shall register under those categories separately.
- V. The Central Pollution Control Board may charge such registration fees from the applicants as may be specified from time to time with the approval of the steering committee.
